

# 2020 NEIGHBORHOOD HOUSE HEAD START ANNUAL REPORT

## Program Information

In 2020, over 940 children and families were served, including 432 in Early Head Start (both Home Based and Center Based) and 508 in Head Start and ECEAP Preschool.

## School Readiness

**Our main educational goal prepare children & families to successfully transition to elementary school. We prepare children by:**



Measuring progress towards School Readiness Goals in each of the five domain areas to help children become Kindergarten ready.



Analyzing data quarterly to inform teaching and home visiting practices & assess each child’s progress towards their individual learning goals.



Parents engaged in virtual meetings with teachers and home visitors to discuss and plan for children’s unique strengths and learning goals.



Surveyed families on their needs at the start of the pandemic and planned developmentally appropriate education service options based on parent feedback.



Partnered with local schools to coordinate virtual parent meetings for kindergarten readiness to ease family transition to the new school. We worked with community partners to ensure children with developmental concerns were identified and parents were able to participate in virtual evaluations when appropriate.

## Parent & Family Engagement

**Parents in our program receive individualized family support services, kindergarten transition support, and referral to community resources. We also offer a range of opportunities for parents to engage in their child’s learning & education. In 2020 our parents participated in:**

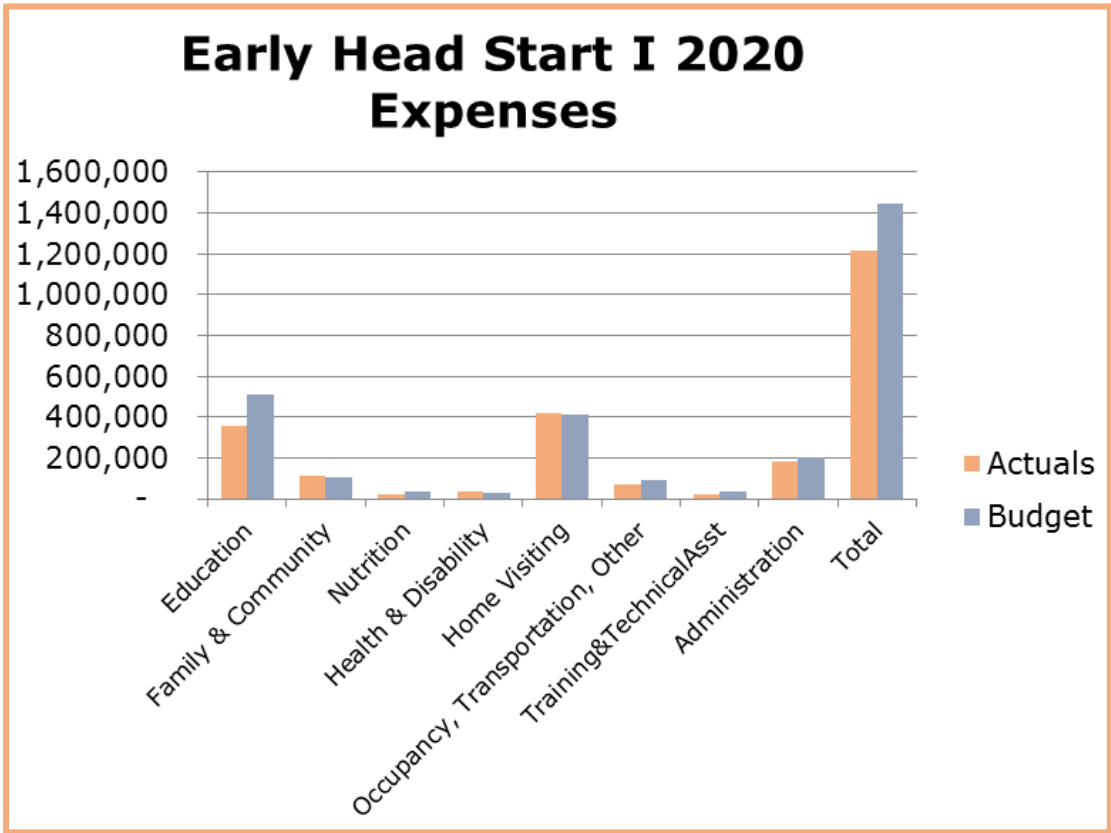

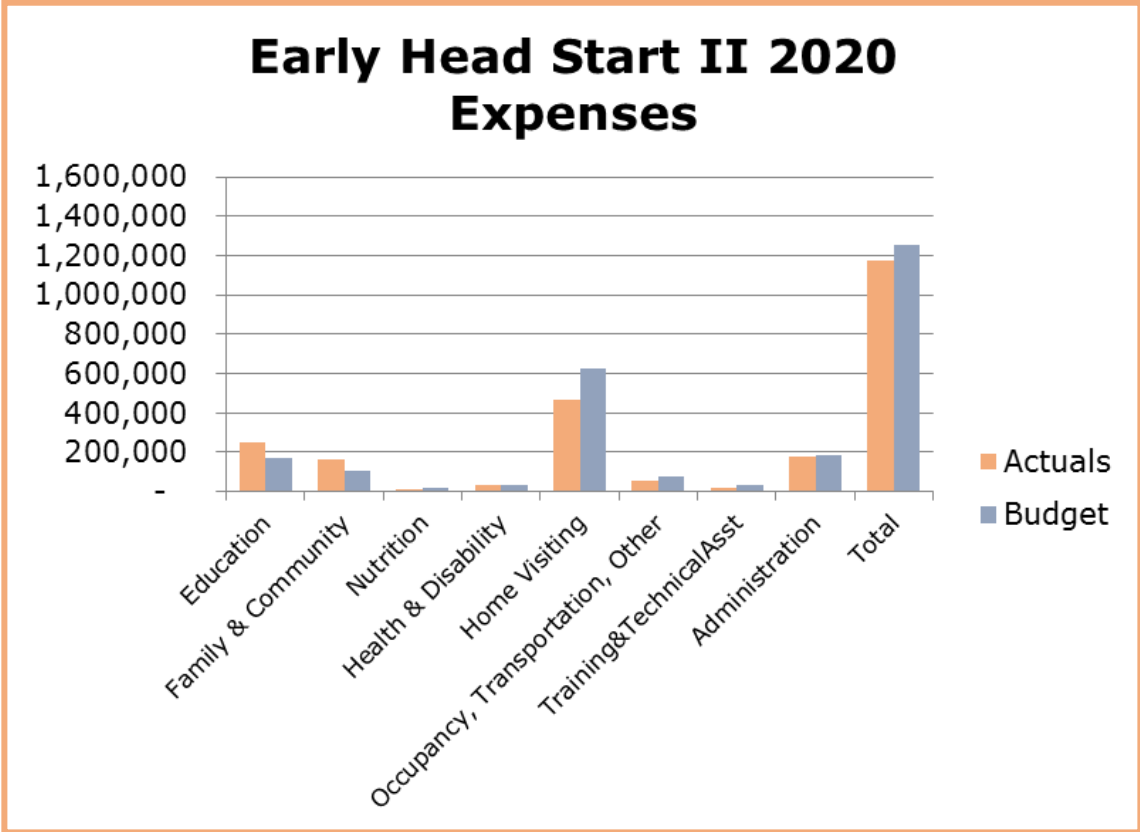

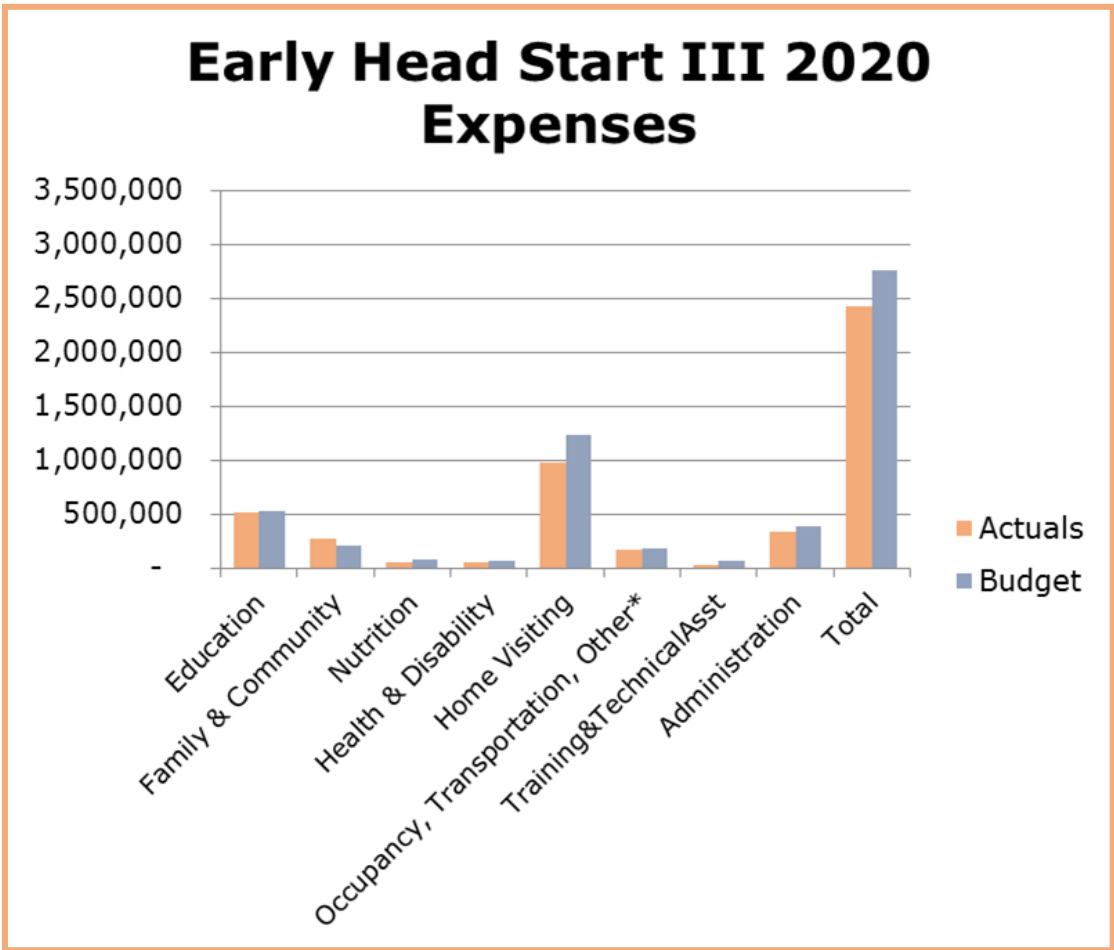
